2015 Used Oil/HHW Training April 8, 2015

Multi-state, industry-sponsored certification program designed to reflect compliance with strict environmental and Best-Management Practices (BMPs) to prevent ocean pollution

Established 2004
 127 certified California marinas
 Santa Barbara certified July 2006
 Recertified June 2011
 OPP integral to this certification



## SB City Clean Marina Program

## SB City adopted its own Clean Marina Program in 2002

Goal: Achieve and maintain Best Management Practices (BMPs) and a clean harbor environment for people, aquatic life and seabirds One of the first public marinas in the state to create its own Clean Marina Program Used Oil Payment Program (OPP) integral to this program



## **Bilge Water Pump-out**

Bilge Water pump-out at Fuel Dock
 Removed 4,635 gallons in 2014
 93% of 12-year average

## Waste-Oil Disposal

Three free waste-oil disposal stations
 Take oil, oil filters, bilge pads, anti-freeze
 CY '13: 5,205 gallons, near 3-year average
 Oil collection tank at Fuel Dock replaced 2013



# Best Management Practices

**BEST MANAGEMENT PRACTICES** 

## **Oil Absorbent Pad Distribution**

Pads mop up bilges and prevent leaks while fueling

Pad Distribution (free to boaters, OPP funded)
 17,500 in FY 2014
 03% above 12-year average

## **Operation Clean Sweep**

Volunteer seafloor clean-up program 15.7 tons of debris removed during eight annual one-day events Bicycles, barbeques, plastic barrels, boat propellers, crab receivers, boat liners, outboard engines and an occasional marine battery This year's event—May 2<sup>nd</sup> Completes 9-year Harbor "circumnavigation" Begins again in 2016

**Compliance & Enforcement** 

## **Discharge Violations**

Proper used-oil disposal taken very seriously

Discharge Violations
FY 2013: Seven warnings (with BMP packets), two citations for spilled oil
FY 2014—no spill violations
FY 2015—no spill violations to date
Warnings and citations have dropped steadily since FY 2005 (29 warnings, three citations)

Steadily increasing culture of responsibility
