What is a Disaster

Definition

- A sudden event, such as an accident or a natural catastrophe, that causes great damage or loss of life.
- The US Federal Emergency Management Agency (FEMA) describes it as "An occurrence of a natural catastrophe, technological accident, or human caused event that has resulted in severe property damage, deaths, and/or multiple injuries."

The real answer

- Dr. Kathleen J. Tierney (Director, Disaster Research Center, University of Delaware) puts the matter in a different perspective:
 - "Many people trying to do quickly what they do not ordinarily do, in an environment with which they are not familiar."

Disaster Operations

- Transitions from Response to Recovery
 - How do you manage this transition?
 - What is the scope and size?
 - What exemption are available?
 - What exemptions are required?
 - What does the plan say?
 - Who is available?
 - What resources are available?
 - Who is FUNDING the removal?

Debris Plans

- Got one?
- No one does!
 - No City, County, or Jurisdiction has an approved FEMA Debris Plan as of 12/2014
 - Sac County did but FEMA has new requirements now

No Plan. Now What?

- How fast can you mobilize and implement resources
- Can you establish protocols
- Exemptions
- Communications
- Public Safety
- HHW type, amount, staging, location

Debris Removal?

- What are your normal procedures now?
- Disposal costs, who is paying for them?
- Exemptions (Ca Haz, DOT, Asbestos)
- Hazardous waste vs OSHA exposures
- Community exposures
- Biggest concern? Contractors, Dust Control, Storm Water, Body Recovery, Trucking, LF Space, Etc.

My Experience


- Providing a leader to the incident who is responsible and in charge of operations
- Using a Plan and understanding the waste
- Using local resources, waste management haulers, subcontractors
- Using a predefined contractor
- Using Incident Command System (ICS)

Steps

- What is your current process?
 - Do you have a super size process
- Write a plan
 - It will change
 - Daily
 - It will be wrong
 - Fix it

 Understand your hazardous and exemptions

- How do you protect your work force?
- Health and Safety Plan





Lessons Learned

- No disaster plans
- No leadership or debris teams for recovery
- State* and Federal disaster programs do not agree on eligible funding
- Lack of funding for local governments
- Lack of training for local and state gov.
- No local or state established disaster teams
