Excerpts from Fact Sheet: "DTSC response in marijuana labs is booming"


- Explosions from the use of butane gas to extract

## City of Huntington Beach, CA

"...the proper disposal of the cartridges certainly would be questionable. I imagine, the cartridges simply went out with all the other household trash."

"The Tehama County/Red Bluff Landfill has uncovered 1,600 canisters in the last six months –this is simply what has been found after self haulers leave the site or during load checks. I suspect much, much more goes undiscovered hidden in dumpster loads that head directly to the Landfill, which creates another risk of explosion."

"...the City of Corning passed an ordinance that bans the purchase of more than 2 canisters of not more than 840 mL in size total per month per consumer within the City limits. Unfortunately the City cannot regulate sales outside of its jurisdiction (online sales are particularly problematic). As such, I expect the problem to continue.

On the disposal side I ultimately would like to see the state pass EPR legislation for butane canisters...l see this as both a disposal issue and a public health and safety issue.

# **Tehama County Ordinance Passed 2/16**

"...our HHW disposal costs for FY 15/16 increased dramatically as compared to FY 14/15 (nearly 25%). Handling these materials is stretching our operating budget quite thin.


While I think the intent of the ordinance was honorable, without restrictions on online ordering, I don't think we will see any real results. In recent weeks, we received nearly 50 canisters of butane from the DA for disposal."

#### What's Next?

- Limit the sale of butane canisters as was done with Sudafed. You can't by pseudophedrine hydrochloride on Amazon any more. You can only by phynelephrine, which cannot be utilized in the manufacture of methamphetamine.
- Regulation of butane on the retail level will have little effect without restricting online sales.
- Regulation without tracking and enforcement will have little effect, hence the need for DOJ to be prepared to set up a similar tracking system of purchase as they did with CURES for opioids.
- EPR for butane canisters similar to ARB small can refrigerant containers
- Other ideas?
