	This session will focus on the benefits of materials management through resource conservation and recovery as it relates to state and local government planning and business assistance. Per USEPA, approximately 42% of Green House Gas (GHG) emissions in the U.S. are associated with material management activities. In addition to increasing material efficiency and reducing waste, materials management activities have the potential to significantly reduce GHG emissions and offer economic benefits for communities and businesses. For example, recycling a ton of material creates many more jobs than sending the same material to a landfill. Participants will also have the opportunity to learn how these and other resource conservation efforts are integrated into statewide and local green business programs, including hearing from a green business firsthand!

	As we continue to reduce waste, funding mechanisms that primarily or exclusively rely on tipping fees are struggling, which is further compounded by the current economic climate. In response, Zone Administrators have requested we explore alternative funding sources that specifically address this issue. Therefore, we will hear from San Jose about a recent adjustment to help stabilize their solid waste management funding mechanism as well as examples of funding HHW, reuse and green technology facilities and/programs with sources other than AB939 or tipping fees. At a number of past Zone Works, we have also had have the opportunity to learn about bonds programs that fold nicely into our RMDZ services at the state and local level. This session will include a case study, walking us through a local example of facilitating a bond process as well as a business that used such a funding option in lieu of an RMDZ loan.
