EHMT Program Goal



To provide the knowledge and skills that allow a person to work with toxic substances in compliance with government regulations while protecting the environment, human health and safety.

The National Need

- **Over 33,000 hazardous waste sites on superfund list**
- **DOE estimates high demand for environmental professional in next decade**
- **DOE - 13 major sites - thousands of remediation areas - estimated clean up \$50 billion dollars.**
- **DoD - 1855 bases with 17,482 polluted sites - greater than 100 superfund sites - \$200 billion dollars**
- **EPA - Clean Air Act enforcement estimated to impact 34,000 facilities, large and small**
- **Public and governmental attention is increasingly focused on environmental quality - protection/prevention, restoration, waste reduction**
- **Need for two-year degree/certificated technicians has been identified as the key near-term problem**
- **Worker health and safety training needs for industry is an ongoing need**

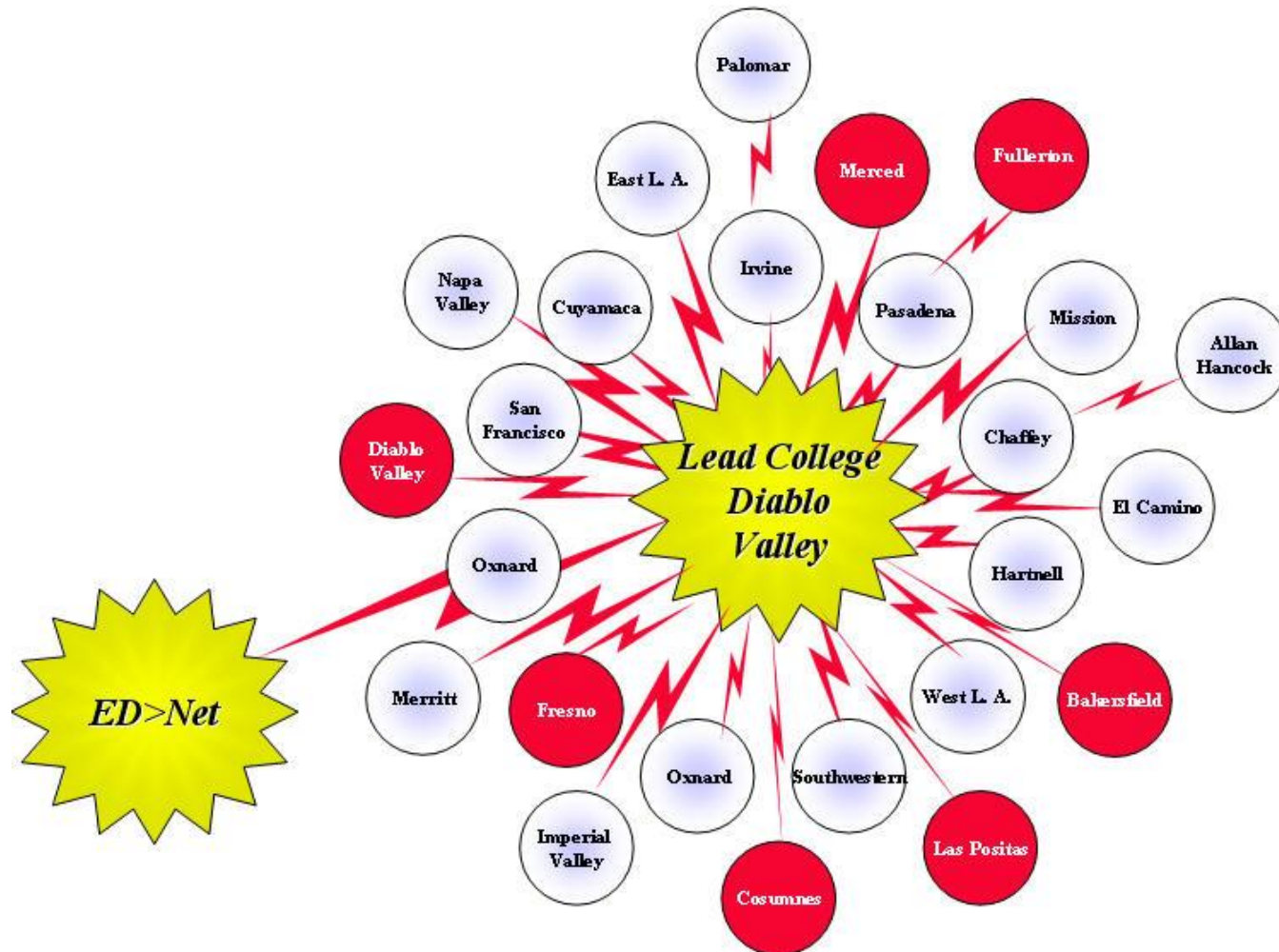

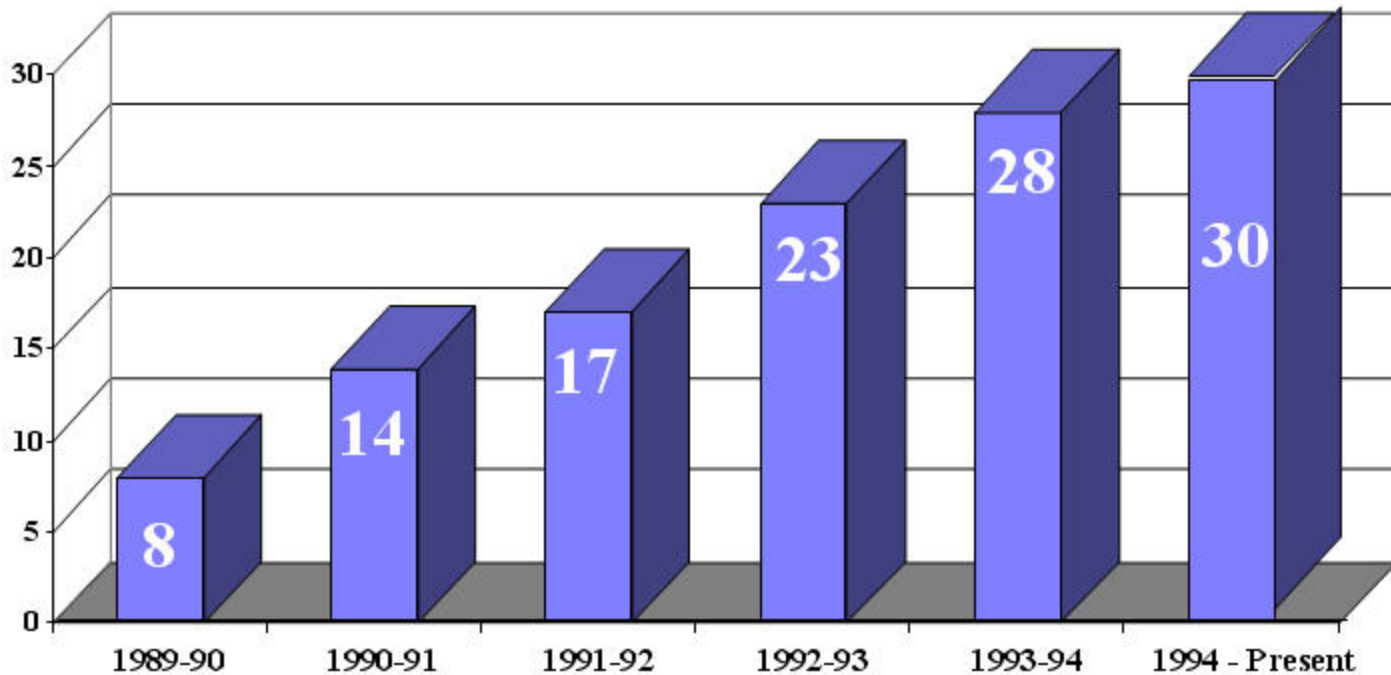
Organizational Structure



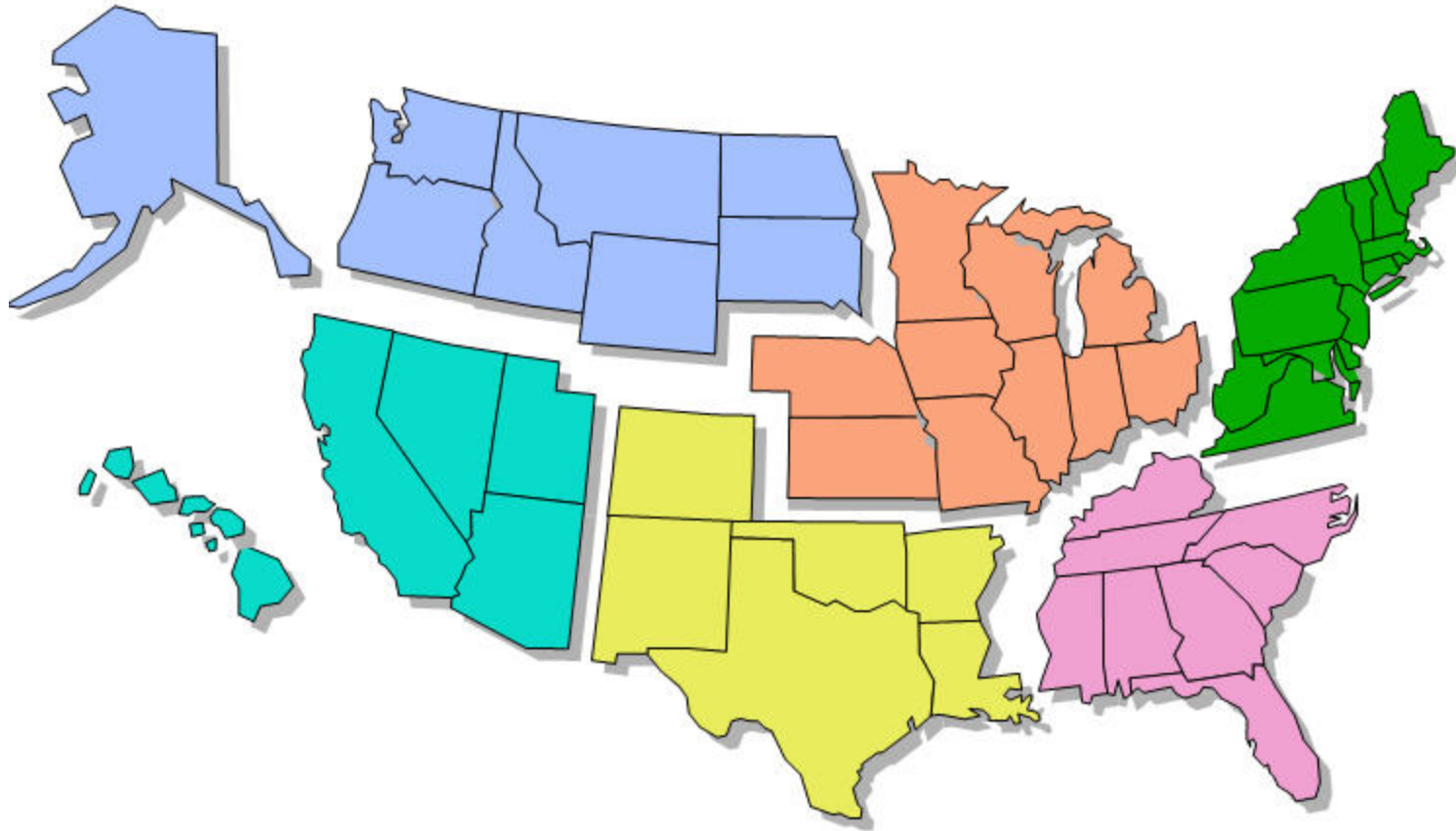
Initial Buildout

Six Regional Programs

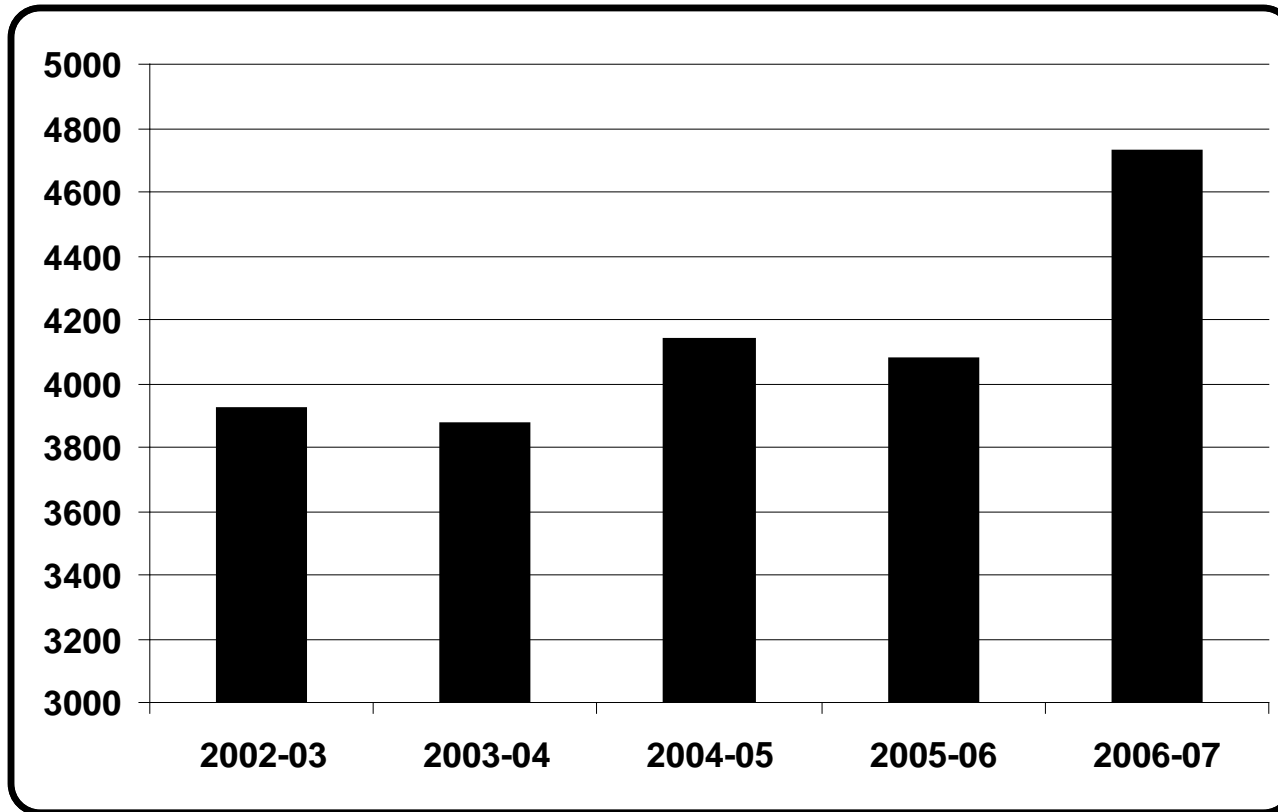


Early Program Buildout

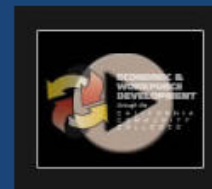

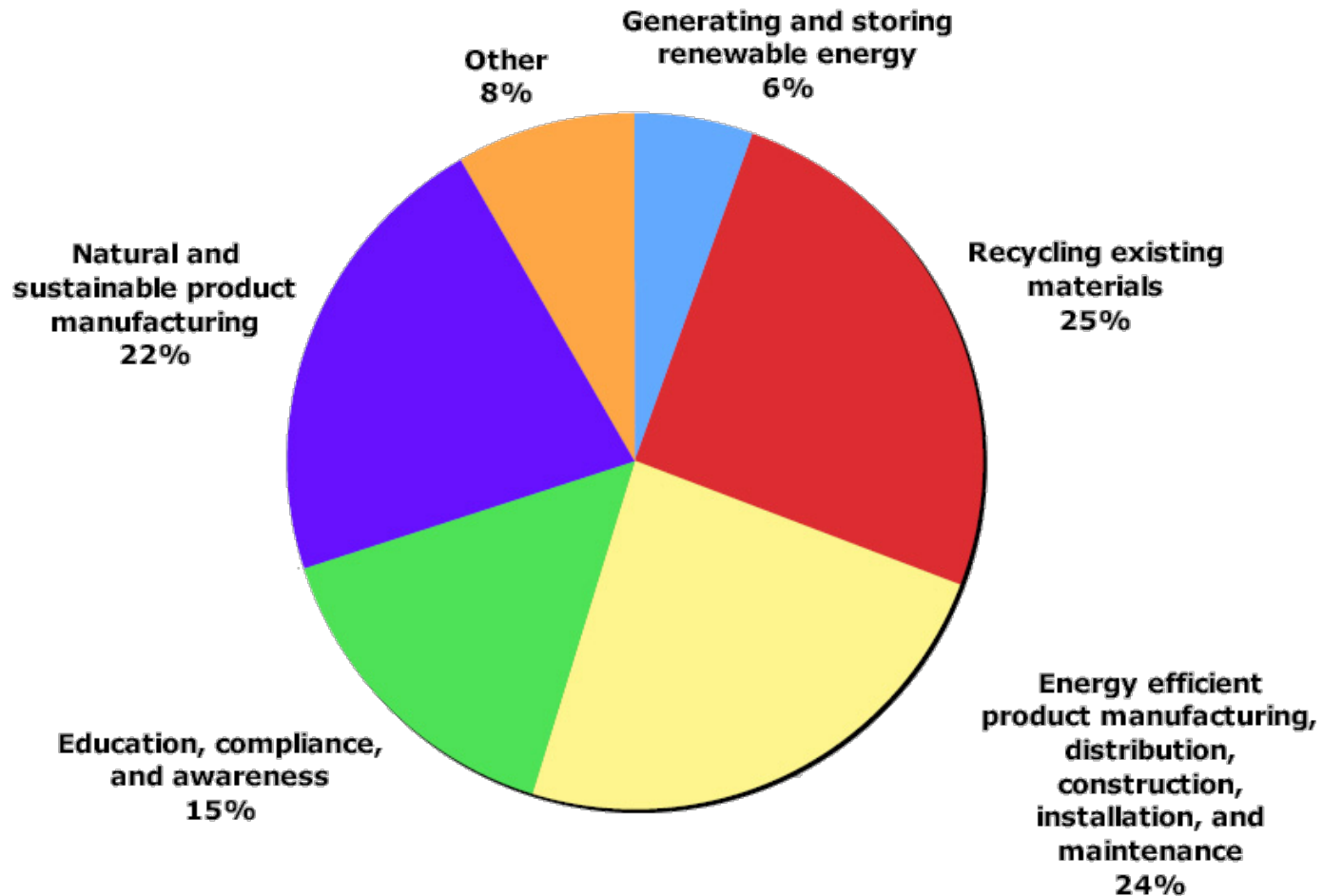

Green jobs produce (“supply”) goods or services that result in:

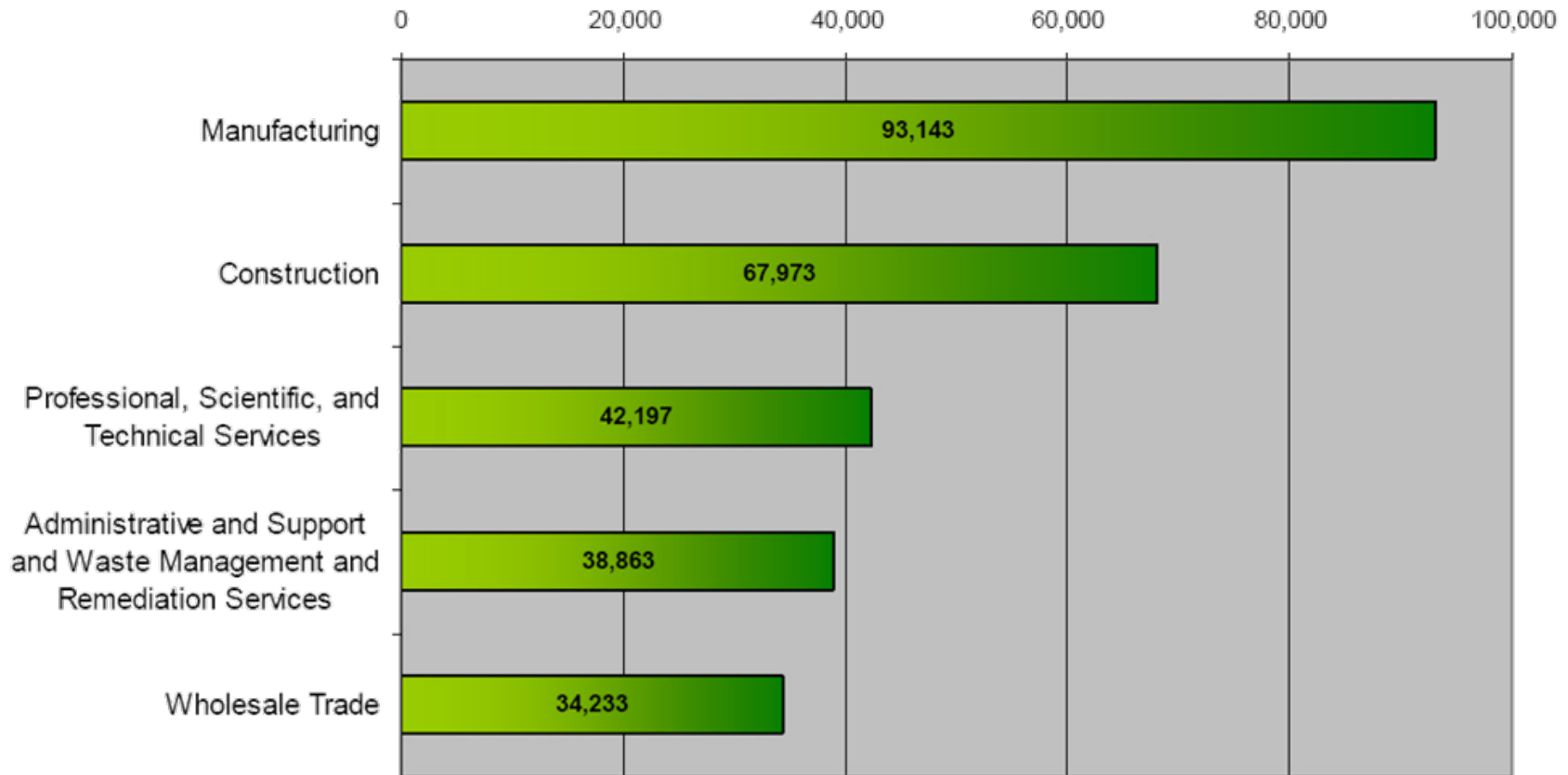
- **Generating and storing renewable energy**

Green Workers Reported



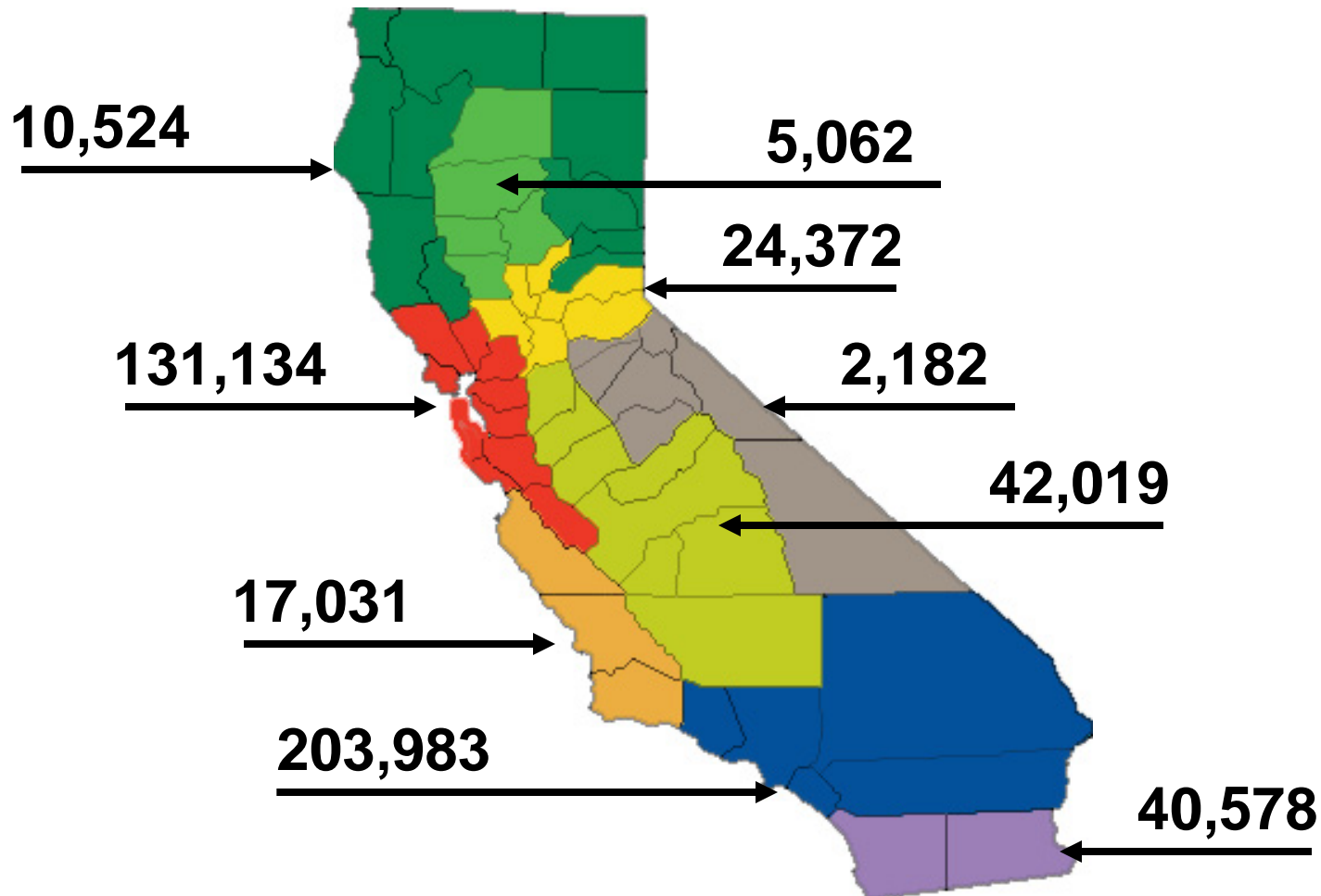

Industries with the Most Green Jobs



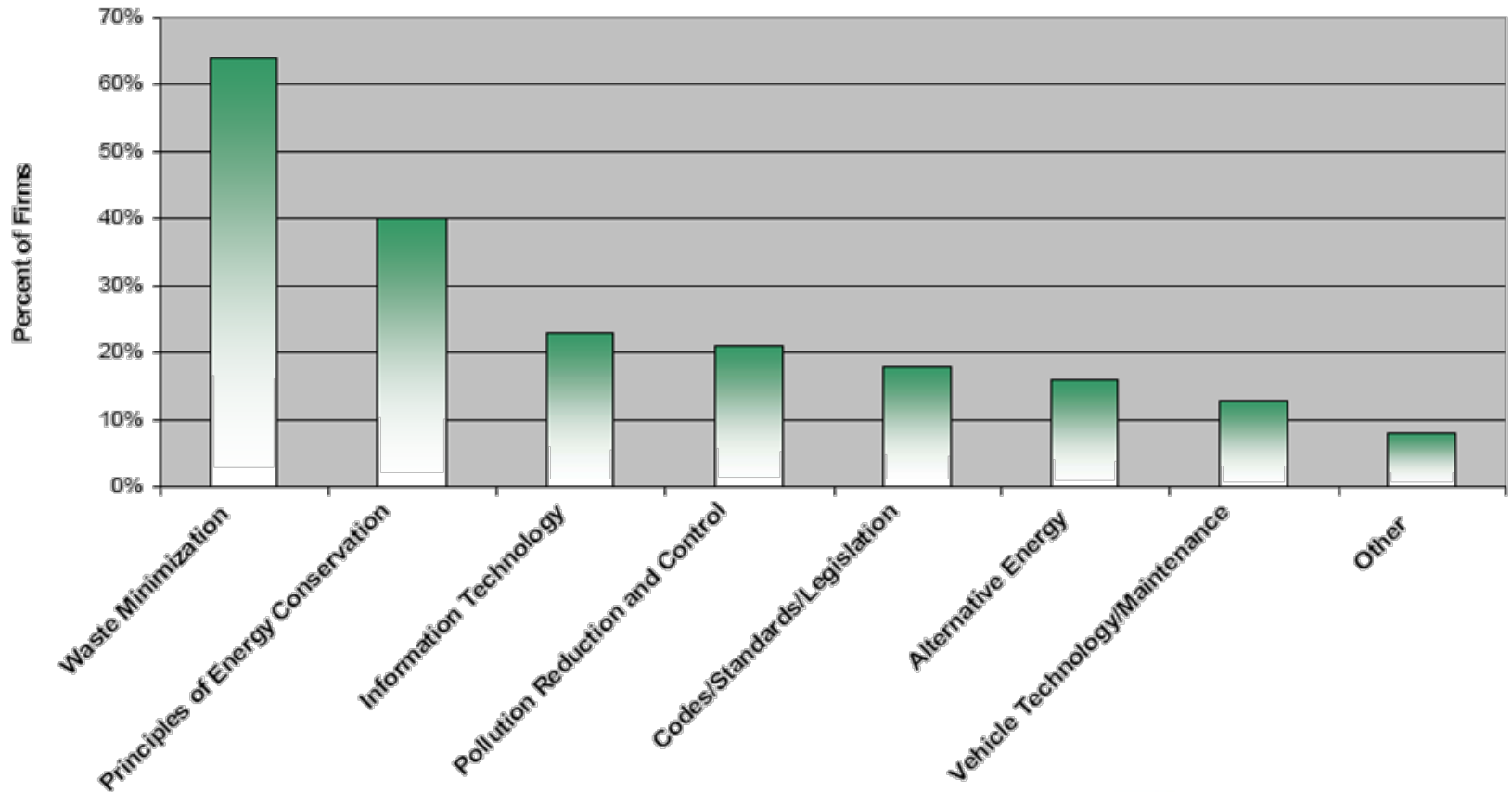

Regional Distribution of Green Jobs

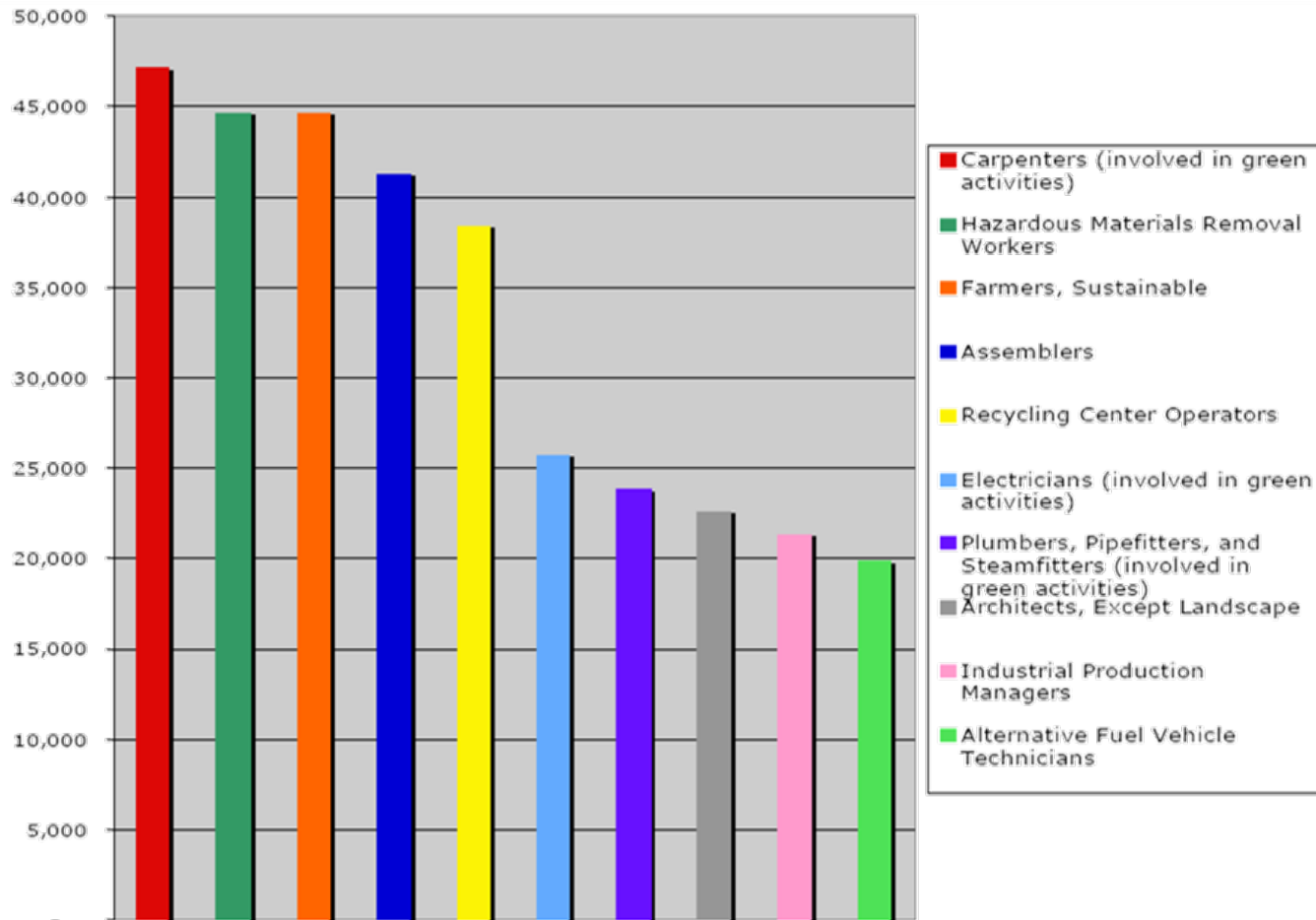


Business Practice Skill Needs

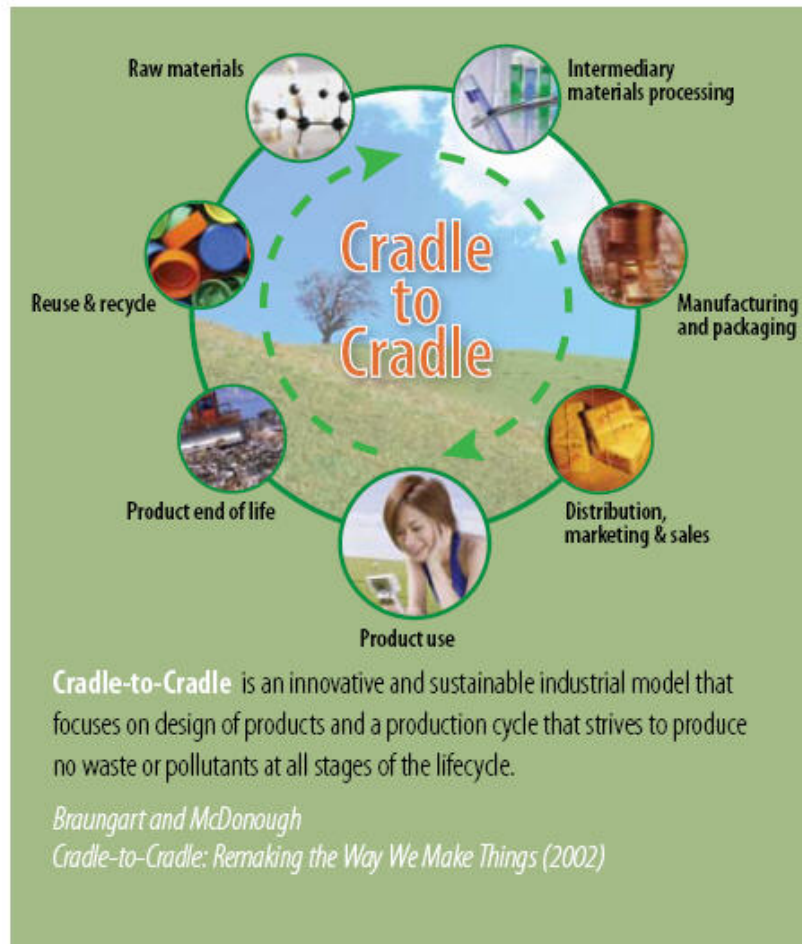
California Green Chemistry

- Green chemistry represents a major paradigm shift that focuses on environmental protection at the design stage of product and manufacturing processes.
- It is an innovative way to deal with chemicals before they become hazards, with the goal of making chemicals and products “benign by design.”
- Green chemistry is a preemptive strategy that reduces the use of toxic substances before they contaminate the environment and our bodies.
