## How to Submit Your ZIF Application

If you are not the ZA for El Dorado, North Coast, Orange County, or Solano County, then:

- 1. If your zone has recently applied for city-county payments or a CalRecycle grant, then the resolution you used for that should work for this too, so send that one to me so that I can review it.
- 2. If you are not in Category 1 above, then send me the resolution you have that may work for ZIFs and I'll let you know if it does or does not.
- 3. If you are not in Category 1 or 2 above, then create a resolution based upon the template that does meet this requirement and send me that draft to review before you ask your council or board to pass it.
